Dear Speaker Pelosi and Leader McConnell:

Since the death of George Floyd in May, many of us continue to find ourselves moved to tears. Our horror at watching this video will be something we can never forget. Catholic Charities USA (CCUSA) remains disturbed by the continued acts of wanton indifference to human life, especially to the lives of our African American brothers and sisters. We believe that each person is made in God's image and likeness with inherent dignity, principles found both in our religious heritage and in the very words of the Declaration of Independence: "We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable rights, that among these are life, liberty and the pursuit of happiness." We need a change of heart and a transformation of public policy to confront systemic racism.

I am writing today for three reasons. First, we lend our support to the establishment of a Commission on the Social Status of Black Men and Boys (H.R. 1636 and S. 2163). As a national network of social service agencies, we are happy to offer information that can be of help in this important work.

Second, we ask you to support HR 35/S. 488, the Emmett Till Anti-Lynching Act and Justice for Victims of Lynching Act of 2019, which establishes a new criminal civil rights violation for lynching.

Lastly, the stain of racism has polluted our public policies for generations with the result that African Americans are more likely to be economically vulnerable than white Americans. Years of over-policing in black communities and unjust sentencing laws have led African Americans to be 6.4 times as likely as white Americans to be incarcerated. Biased financial lending practices and redlining have stripped from African American families the ability to build family wealth through homeownership. Additionally, according to the Bureau of Labor Statistics, the unemployment rate for African Americans is about double the rate for whites and has been for most of the last six decades. There must a bipartisan effort to address this historic inequity. Sadly, the recent COVID-19 pandemic also demonstrates that minorities continue to be disproportionately affected.

As Congress considers various public policy proposals we encourage you to pursue a holistic and integrated approach to racial justice, including priorities such as:
